INTRODUCTION TO THE COVID-19 PREVENTION PROTOCOL

Due to the COVID-19 pandemic, the AUDI FIS Ski World Cup in Val di Fassa (TN – Italy) scheduled from February 24th to 28th 2021 must be held under increased security measures.

According to the current national and local regulations, as well as to the FIS prevention measures and to the Organizing Committee (LOC) dispositions, we hereby send the protocol of instructions to be taken by Media while in Val di Fassa, on occasion of the event taking place at Passo San Pellegrino from February 24th to 28th 2021.

This is part of a wider project of Prevention and Safety against COVID 19 adopted by the LOC, in partnership with the local authorities to protect the workers' health and the entire community as well.

By registering for this event, each media representative entirely confirms and accepts the contents of this protocol of measurements for the above mentioned event and agrees to respect it for everyone's health.

This protocol contains general and specific measures of prevention covering behavioural and organizing requirements, both collective and individual.

GENERAL PREVENTIVE MEASURES

1. Distance and protection

It is mandatory to maintain in every situation and condition interpersonal safety distance of at least 1 meter (social distancing) and to wear Individual respiratory Protection Equipment (respiratory IPE) in all indoor areas, except for private living quarters, and in all outdoor places, apart from all the specific situations where it is possible to guarantee a continuous condition of isolation.

Anyway, it is strongly recommended to use the respiratory IPE inside the private living quarters (e.g. Hotel rooms) too when in presence of not permanently cohabitant people.

Therefore, unless otherwise specified:

It is mandatory to always wear a protection to mouth and nose (face mask) on the entire location of the event, except:

- inside the private living quarters (e.g. Hotel rooms);
- during mealtimes;

2. Sanification

The use of the Individual respiratory Protection Equipment (respiratory IPE) is complimentary to the other measures of control of the infection such as the constant and careful hand hygiene and the disinfection of equipment and materials.

3. Rules of Conduct

From 10.00 P.M. to 5.00 A.M. the only allowed movements are for demonstrated needs (e.g. Health reasons). During the rest of the day, it is strongly recommended to move from your accommodation for purposes relating the event activities only, taking care, wherever possible, to avoid any gatherings.

4. Avoid gatherings

It is mandatory for all the public places, cabins ski lift and adjacent access spaces included, to expose at the entrance signboards indicating maximum number of people simultaneously allowed. Everybody must observe this maximum number of people allowed in. We recommend a good and punctual organization to avoid any delay on the fixed time because of any long wait.

To reduce at the minimum the risk of infection, the LOC advise to all the people involved to:

- Remain in small groups;
- Avoid teams contact;
- Avoid LOC staff contact;
- Avoid tourist and fans contact;
- Hold interviews inside the racing venue mixed zone only, at distance and with Individual respiratory Protection Equipment (respiratory IPE);
- Properly and periodically wash and sanitize your hands;
- Have a documentation of your current state of health.

SPECIFIC PREVENTIVE MEASURES

1. Working in Italy and Travel Restrictions

In Italy only events and competitions organized by National and International Sports Agencies are currently allowed, without any audience (so-called “closed events”). The athlete workout sessions are allowed without audience too, still according to the Federation protocols and in respect of the social distancing of at least 2 meters.

If you are travelling from abroad, please notice that, according to the DPCM 14.01.2021 and to the latest rules (see <https://www.esteri.it/mae/en/ministero/normativaonline/decreto-iorestoacasa-domande-frequenti/focus-cittadini-italiani-in-rientro-dall-estero-e-cittadini-stranieri-in-italia.html>), in order to be admitted by the local government and by the local health system, you MUST take a PCR or antigen test not earlier than 48 hours before coming to Italy. Furthermore, you will need to inform the Prevention Department of the local health service of your arrival, by sending an email to segreteria.uoisp@apss.tn.it. Attached to the email, you will have to send a Self-declaration form (filled out and signed – see the Appendix at page 14), together with a copy of your I.D. and a copy of the negative result of the test. Please notice that you will also have to bring this document with you while travelling towards Italy and show it if asked to.

For everyone else, who must yet upload on his own FIS passport a negative molecular or antigen test before getting to Val di Fassa, a sampling point will be available *by the COVID-19 Test and Health Center* located at the Navalge centre in Moena during the whole duration of the event, from 24th to 28th February 2021, between 9.00 a.m. and 12.00 p.m. and from 3.00 to 6.00 p.m.. The service will be carried out by the Dolomiten Trauma Clinic (tel. +39 335 445917) and the COVID-19 responsible for the LOC will be Dr. Orazio Braghenti.

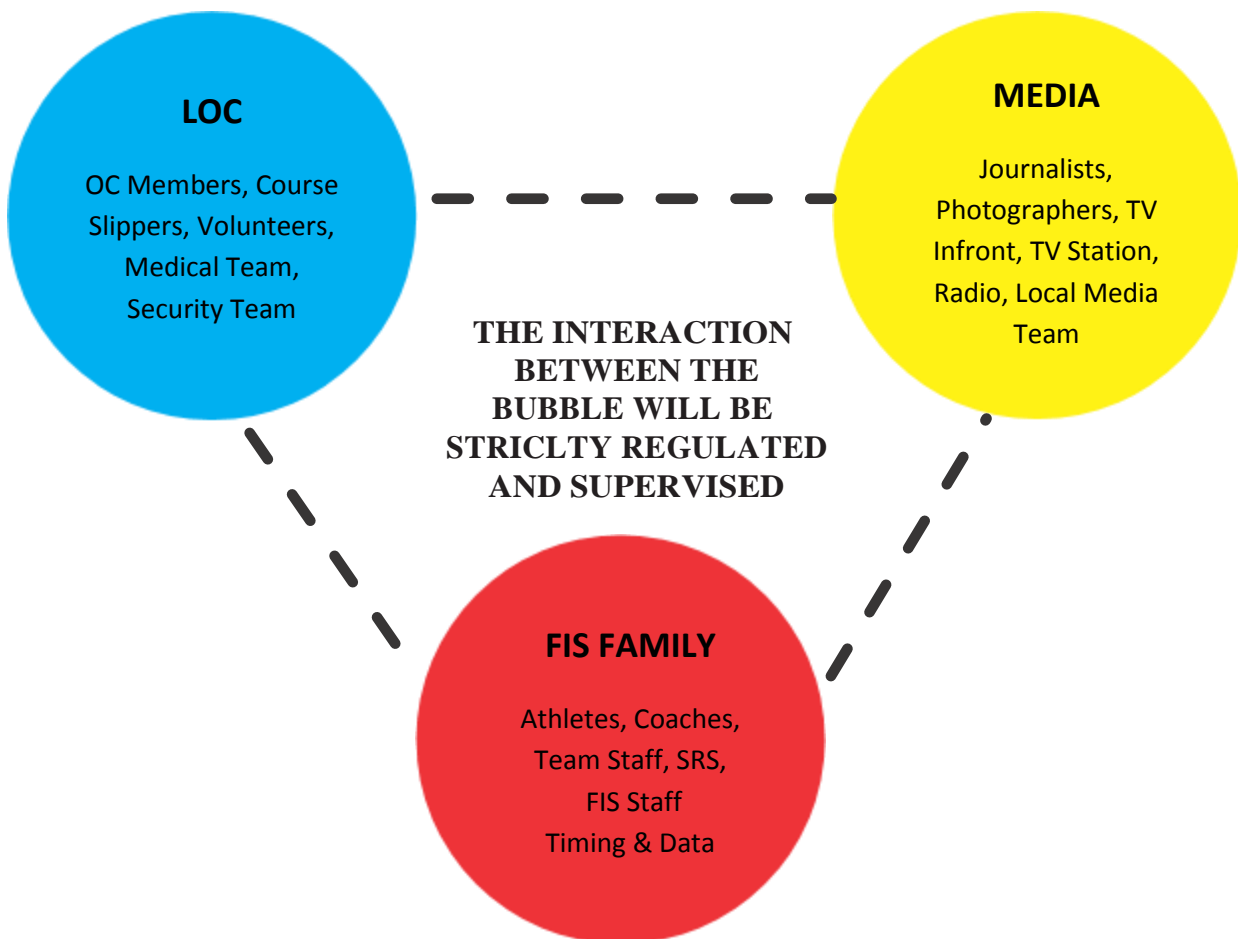
2. Journey to Val di Fassa

- In case of COVID-19 symptoms, do not travel to the venue.
- Avoid any stop between the departure point and the event location.
- Avoid contact with other people – especially if not part of your team.

VAL DI FASSA SKI WORLD CUP PREVENTION PLAN CONCEPT

According to the FIS Prevention and Mitigation Guidelines, one of the core elements to guarantee a good level of safety shall be creating different “bubbles” (“FIS Snowflakes”) gathering different groups. People being regularly tested and being disciplined according to rules and regulations should limit any interaction with persons not being subject to strict protocols.

Bubbles System



For each group specific prevention measures are envisaged relating to the various operational activities. There are also operational locations and differentiated flows that limit the interaction between the different bubbles.

The following information will provide the necessary information for the individual groups (YELLOW BUBBLE) in order to describe all the specific measures and useful information.

VAL DI FASSA SKI WORLD CUP – INFORMATION FOR TEST AND TEST PROTOCOL

Media representatives, via the FIS PASSPORT online system, must present a negative antigen or PCR test not older than 72 hours. Test result must be uploaded at least 24 hours before the arrival on the FIS passport platform (<https://fispasport.fis-ski.com/fis/>). A positive result will cause the exclusion from the race and withdrawal of accreditation.

By the *COVID-19 Test and Health Centre*, during the whole duration of the event, it will be possible to undertake antigen and PCR tests at a reduced price (€ 45 antigen test; € 130 PCR test), upon reservation at the +39 0462 888014.

Covid-19 Communication

- In case of symptoms, immediately inform the COVID-19 responsible for the LOC, Dr. Orazio Braghenti (Mob. +39 338 8642235).
- The LOC will activate the COVID-19 rescue chain.
- All communication regarding COVID-19 must be coordinated with the FIS and the LOC.

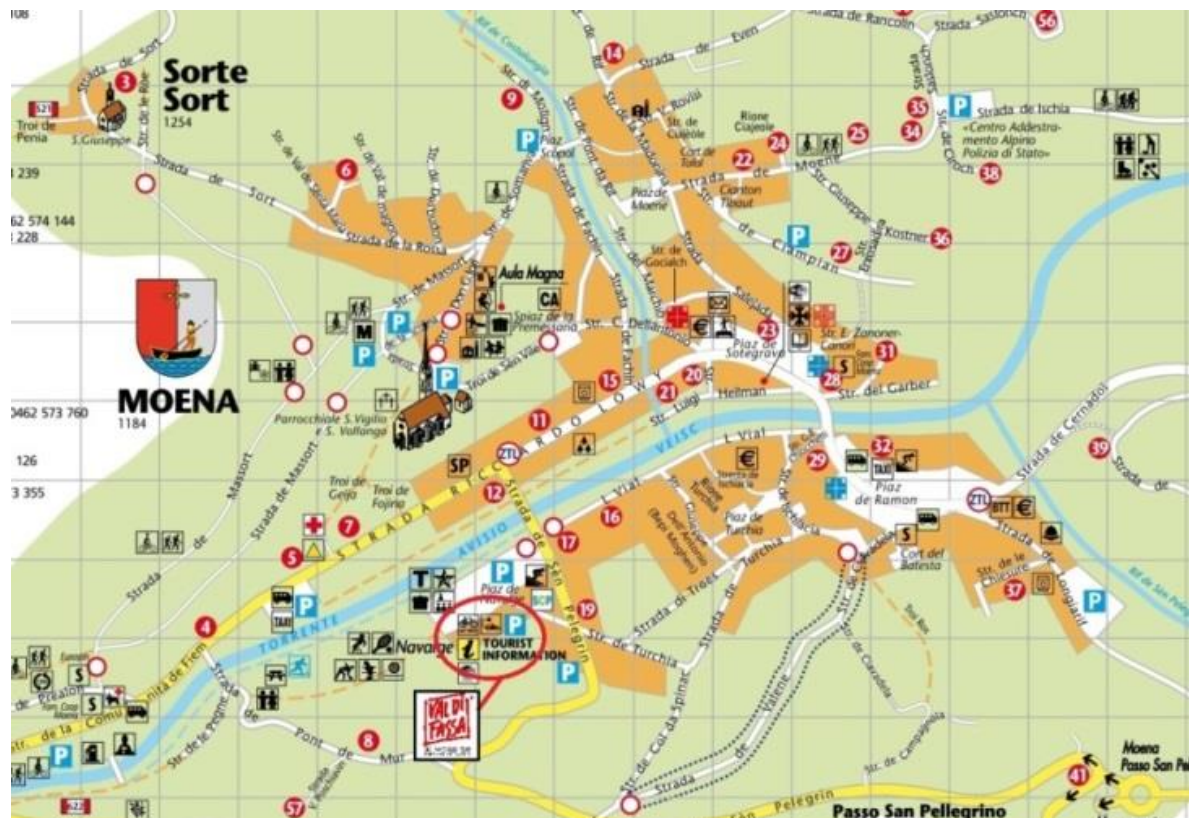

Due to the current situation, the LOC must limit the number of accredited persons, we therefore remind all the stakeholders to reduce the accreditation request to the necessary number of people who are really involved in the World Cup Races.

In addition to the FIS PASSPORT PLATFORM, the accreditation system of the LOC, EventBuilder will be the operating platform that will activate all the necessary steps to validate the request and issue the accreditation (data collection, test verification by the doctor, collection of medical questionnaires).

The accreditation can be obtained only after the EventBuilder application process has been completed. For any needs, the reference email is press@valdifassaskiworldcup.it.

Please note that specific protection measurements have been adopted on the event site to protect the LOC employees and all the people involved in the event. These measures must also be observed by the media when approaching the staff. These provisions are contained in the COVID 19 protocol adopted by the LOC and available on the website.

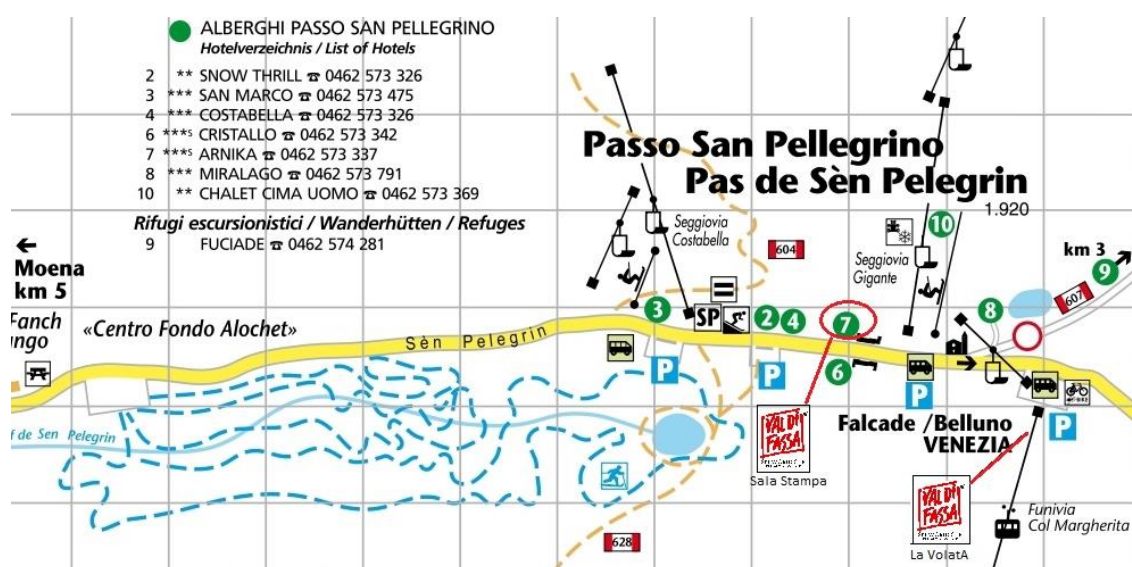

The access will be limited to Media accredited people. Temperature will be measured at each access. In case of temperature symptoms, the media representatives will not be allowed in the Press Room

Everyone will be assigned a **work station** by the person in charge of the Press Room. We kindly ask you to keep the same workspace during the whole duration of the event. The media representatives will have to wear face masks inside the Press Room, while being allowed to remove it when sat at their assigned post.

FINISH AREA MIXED ZONE REGULATIONS

Temperature will be measured at each access in the Finish Area Mixed Zone: in case of temperature symptoms, the media representatives will not be allowed to enter the area.

Due to the Covid-19 measures and social distancing prescription, only 70 people will be allowed to enter the Mixed Zone. To those media who have not requested it or have not been granted, access to the Mixed Zone will not be allowed.

The media representatives will have to wear face masks all the time inside the Mixed Zone and respect the distancing provisions.

TV/RADIO COMMENTATORS BOXES REGULATIONS

Only TV and Radio Commentators will be allowed inside the dedicated facility, with temperature measured at each access. In case of temperature symptoms, the media representative will not be allowed in the area.

The media representatives will have to wear face masks inside the facility, while it can be removed when at the microphone station.

ON COURSE PHOTO POSITION REGULATIONS

Due to the COVID-19 provisions, the access to the on-course photo positions will be restricted to 20 professionals, donning an arm band or bib that will be assigned by the responsible for the photographers (Mr. Alessandro Trovati).

Photographers will not be able to enter the finish areas to take photos of the ceremonies. Instead, the podium will be placed in such a way that photos of the ceremony can be taken from the photo stands.

EVENT AREA: GENERAL MEASURES

- Keep the social distancing
- Stay in assigned and marked media zones
- The media area (mixed zone) is delimited and accessible to the accredited persons only
- Avoid any direct contact with other groups (teams, employees)
- Mouth and nose protections must be worn while at the venue
- If a media member feels sick or exhibits COVID-19 symptoms, contact the COVID-19 LOC responsible for the LOC, Dr. Orazio Braghenti (Mob. +39 338 8642235). The COVID-19 responsible will be on-call 24/7, from the official day of arrival to the official day of departure.

GENERAL RECOMMENDATIONS

We appeal to EVERYONE to take their own responsibility and to comply and implement all measurements and recommendations given!

Guidelines are used to implement or control compliance with the COVID-19 specifications. For your own safety and for the safety of other people, you must follow the instructions of the operational staff.

We reserve the right to exclude you from the event and to take legal action in the event of non-compliance with the COVID-19 regulations.

The defined measurements were determined in accordance with the current regulations (on the day of the issuing of this document, 17.02.2021).

The organizer reserves the right to make any necessary change, which will be announced straight.
